DESCRIPTION

Mule-Hide SEBS 1 Sealant is a high-performance, multipurpose thermoplastic elastomer based roofing sealant. It exhibits excellent adhesion to most surfaces including metal, Kynar finishes, asphalt, shingles, modified bitumen, EPDM, TPO, PVC (Elvaloy only), Hypalon, vinyl, fiber cement, wood, concrete, tile, masonry and glass.

BASIC USES

Mule-Hide SEBS 1 Sealant is used to seal seams, flashings and penetrations on all types of roofs. Ideal for residential applications where appearance is important.

PACKAGING

Container size: 10 oz. tube, 30 per carton

APPLICATION

- 1. Surface to be sealed must be clean and dry.
- 2. Maximum joint width and depth for sealant applications is 3/8". Use backer rod in deep joints.
- 3. To use, cut tip to desired size and puncture seal.
- 4. Minimum depth of application is 1/4" thick, edges are to be tapered.
- 5. Keep product warm prior to using. For best results maintain SEBS 1 at 70° or higher.
- 6. SEBS 1 Sealant may be painted. Some paints may require up to one week cure time of sealant beforeapplication.

Application instructions are basic guidelines only. Please read and understand the complete Mule-Hide specification for this product prior to use.
